## 2007 USMS Two-Mile Cable National Championship

Mirror Lake in Lake Placid, New York  
Saturday, August 18, 2007, 10:30 am

**Event:** This will be a 2-mile swim, consisting of four laps around a quarter-mile course over an underwater cable marked with buoys. There will be two heats. The first heat will swim in a counter-clockwise direction starting at 10:30 AM; the second heat will swim in a clockwise direction upon the completion of the first heat.

**Check-in:** Heat 1: 9:00-10:00 AM. Heat 2: closes at 11:15.

### NO RACE DAY ENTRIES

**Eligibility:** Open to all swimmers 18 years & over as of August 18, 2007. All swimmers must be registered with USMS or MSC. You must submit a copy of your 2007 registration or a completed One Event Registration Form (\$15), or a completed Annual Registration Form (\$30). Entries without a copy of the 2007 USMS/MS card or a completed registration form will be returned.

**Entries:** All entries must be received by **Tuesday, August 7**. LATE AND RACE DAY ENTRIES WILL NOT BE ACCEPTED. Entry fee is \$40.00. Fee includes a 100% cotton T-shirt. Indicate size on entry form. (For T-shirts larger than XL, please add \$3.00 and indicate size.) To guarantee T-shirt size, entry must be received no later than **Wednesday, August 1**.

**Safety:** For safety reasons, swimmers who cannot complete 2 miles in 1-1/2 hours are advised not to enter. Swimmers still on the course after the time limit will be stopped and listed as DNF in the results. In the event of inclement weather, the race director may close the course and thereby prevent swimmers from completing the swim. Entry fee includes a highly visible swim cap that must be worn during the swim. No motorized craft are allowed on the lake. Paddlers will provide safety.

**Water temperature:** 70-80°F.

**Wetsuits** may be worn but swimmers will have a separate start and finish. Times will be posted in a separate category and are not eligible for USMS National Championship awards or record consideration. If you plan to wear a wetsuit, you must declare it on your entry. Changes may not be made on race day.

**Seeding:** Swimmers will be seeded fastest to slowest according to 1650 seedtime and will be started 10 swimmers at a time. "No Time" will be seeded in the slower waves of each heat. Races will be seeded before race day, so seeding changes will not be allowed on race day.

**Awards:** USMS National Championship medals will be awarded to the top 6 men & women finishers in each age group: 18-24, 25-29, 30-34...100+. USMS National Championship patches will be awarded to the winner of each age group. **One event registrants** will not be eligible for records or All-American status. There will be a separate category for wetsuits. Results will be posted at [www.adms.org](http://www.adms.org) or sent to you if so indicated on the entry form.

**Post-race Picnic & Awards Ceremony:** Free for all entrants and volunteers. Guests over age 10, \$5.00.
